

Helping You Achieve Meaningful Use of Electronic Health Records & Receive Federal Incentives

What is the Arizona Regional Extension Center?

Now is the time to adopt electronic health records (EHRs)—and there is help to do it! Over \$700 million has been made available to non-profit organizations nationwide to establish Health Information Technology Regional Extension Centers to assist primary care providers adopt and become Meaningful Users of EHRs and receive federal incentives, if eligible.

Within Arizona, Arizona Health-e Connection (AzHeC) was awarded funding to develop a Regional Extension Center program to serve Arizona healthcare providers. The program is a collaboration of AzHeC, Arizona State University's Department of Biomedical Informatics and Health Services Advisory Group.

For eligible Medicare providers, up to \$44,000 per provider is available over a five-year period; eligible Medicaid providers can receive as much as \$63,750 over six years.

What Can the Arizona Regional Extension Center Do for Healthcare Providers?

The Arizona Regional Extension Center will serve as a neutral source for credible EHR and HIT information—something much needed as healthcare providers seek to navigate EHR options and select vendors who meet new federal Meaningful Use requirements.

The Arizona Regional Extension Center will also strive to fully identify and provide solutions to the challenges Arizona healthcare providers face in adopting EHR systems. Finally, and most important, the program will provide critical services to EHR adoption as outlined in Table 1 below.

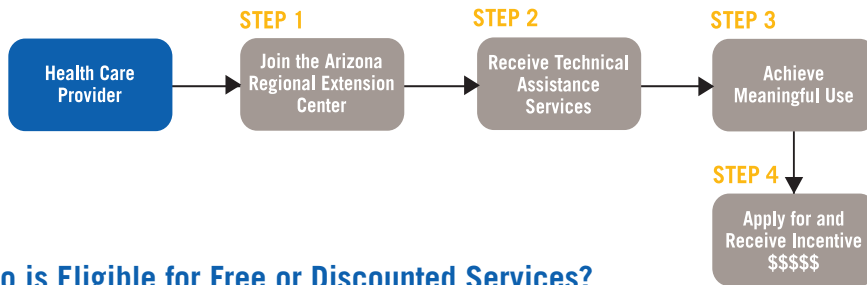

What is the HITECH Act?

In 2009 federal funds made available through the Health Information Technology for Economic and Clinical Health (HITECH) Act, a component of the American Recovery and Reinvestment Act of 2009 (ARRA), created an unprecedented investment in and opportunity for health information technology (HIT) in the U.S. Through ARRA, it is estimated HIT investments may reach \$40 billion over the next eight to 10 years. The final goal of the HITECH Act is to establish an electronic health record (EHR) for each person in the U.S. by 2014!

Who is Eligible for Free or Discounted Services?

Any Arizona healthcare provider is eligible for Arizona Regional Extension Center services, which will be provided at reasonable, needs-based fees. However, only providers that meet criteria in Table 2 below will be eligible to receive free Arizona Regional Extension Center membership (providers must be one of the first 1,958 qualified to sign-up to receive free membership and services) or discounted services. Among Arizona’s estimated 6,700 primary care providers, AZHeC estimates 95 percent will qualify for free or discounted services. <p>Primary care providers (physicians, physician assistants or nurse practitioners with prescriptive privileges, practicing in family medicine, general/internal medicine, OB/GYN or pediatrics) in any of the following settings:</p> <ul style="list-style-type: none"> • Individual and small group practices (ten or few professionals with prescriptive privileges) primarily focused on primary care • Public and Critical Access Hospitals • Community Health Centers and Rural Health Clinics • Other settings that predominantly serve uninsured, underinsured and medically underserved populations <p>* Unsubsidized assistance available to all providers, subject to availability. / Free services are subject to compliance to an agreed upon Project Plan.</p>

What is Meaningful Use?

Under ARRA, Medicare and Medicaid incentive payments will be available to eligible healthcare providers. In order to receive incentive payments, providers must demonstrate “Meaningful Use” of a certified EHR system.

The Five Meaningful Use Categories

- Improve quality, safety, efficiency and reduce health disparities.
 - Engage patients and families in their healthcare.
 - Improve care coordination.
 - Ensure adequate privacy and security protections for personal health information.
 - Improve population and public health.
- Spread across these categories are individual criteria that comprise Meaningful Use. See our website for complete details.
