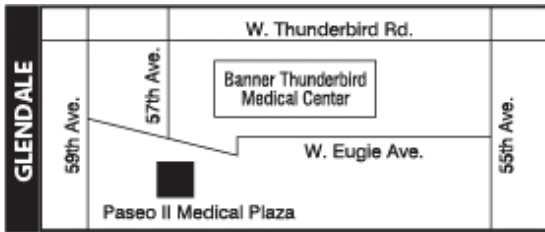

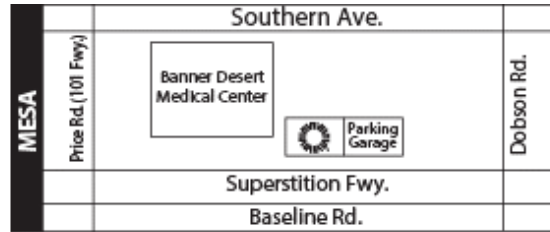
- Available for PT/INR testing only.

- Depending upon your Fingerstick PT/INR test results, a blood collection may be needed for confirmatory testing.
