The Centers for Disease Control and Prevention (CDC) and United States Preventative Services Task Force (USPSTF) recommend pre-exposure prophylaxis, or PrEP, for patients at risk for HIV infection.

Here are the facts:

PrEP is a daily pill (tenofovir and emtricitabine) for patients who want to prevent HIV infection from exposure to the virus through sex or injection drug use

Patients must commit to taking the drug every day and seeing their healthcare provider for follow-up every 3 months

A panel of laboratory tests must be performed prior to and during treatment

With HIV PrEP Panel, HIV prevention is just one test code away

HIV PrEP Panel includes all the CDC guideline-recommended tests you need in order to determine clinical eligibility for PrEP¹ including:

- Documented negative HIV test before prescribing PrEP and throughout treatment
- Normal renal function, no contraindicated medications
- Documented negative hepatitis B virus infection and vaccination status

The patient must also present with no signs or symptoms of acute HIV infection.

Which patients to consider for testing¹

According to CDC guidelines, patients who may benefit from PrEP testing include:

- Anyone without HIV who is at very high risk for getting it from sex or injection drug use
- Couples in which one partner is HIV-positive and the other is HIV-negative
- Anyone who is HIV-negative and self-identifies as at risk or doesn't know the HIV status of their sexual partner(s)

The CDC recommends that individuals at a higher risk for developing STIs are tested at appropriate anatomic sites of exposure, including urethral, rectal, and pharyngeal. Sonora Quest Laboratories offers STI testing with collection devices that aligns with this recommendation.
